### **Livingston Business Improvement District Minutes 8:30 am – Friday – March 27, 2015 Murray Hotel Conference Room**

Roll Call – Board members present were: Dan Kaul, Kristen Galbraith (invitee), Dale Sexton, David Depuy, Betty Lahren, Karla Pettit, Tyler Erickson. Also present were Terri Chambers, Lou Ann Nelson from Chamber of Commerce, and Randy Chambers.

February 27, 2015 Meeting Minutes not yet reviewed by board members. To review before next month's meeting.

#### Public Comment on Non-Agenda Items –

a) From Katabatic Brewery, Brice Jones made a presentation for a Beer event in Livingston called "MT on Tap" and was seeking sponsorship assistance. Discussed benefits of events like this bringing to Livingston and various levels of sponsorship opportunities. Board discussed and Dan suggested \$2000, seconded by Karla and all voted in favor of this \$2000 sponsorship to MT on Tap event in mid-May 2015.
